

Sandy Snodgrass Facing Fentanyl Administrator/Alaska

Scope of Work

10/26/21 my only child, Robert Bruce Snodgrass, was poisoned to death by Fentanyl in Anchorage Alaska. When I received the toxicology report confirming Fentanyl I made a decision that I would face and fight Fentanyl as long as I was able and effective.

At the time of Bruce's Drug Induced Homicide I was working as a Clinical Psychologist. I hold a Dual Master's Degree in Education and Psychology with a Minor in Justice. I took a paid 3 month sabbatical and then left my practice. I have not returned to my profession.

Beginning in January of 2022 I began working full time as a community activist dedicated to increasing prevention, education, awareness and criminal justice related to the dangers of illicit Fentanyl. I have been self supported in my work to date and am now seeking funding to enable my efforts and expand and increase my effectiveness.

The following is a summary of the progression of my work to date. If you google my name, many of the endeavors that I have been involved in are documented by the media and can be viewed there. I believe with the proper funding I will be able to continue and expand my endeavors and I am asking for your support. My belief is that we are Stronger Together.

JANUARY/FEBRUARY

KTUU interview telling Bruce's story and addressing the Opioid Crisis in Alaska.

Attended Mat-Su Opioid Task Force Meeting. Met Michael Troster, Director of the High Intensity Drug Trafficking Area (HIDTA) federal program.

Meeting with US Senator Dan Sullivan and Michael Troster to discuss Opioid Crisis in Alaska. Specifically, topics surrounding interdictions, US Postal Service Inspectors, prevention and education.

Meeting with US Senator Lisa Murkowski and Michael Troster to discuss Opioid Crisis in Alaska. Resulted in Senator Murkowski beginning the process of writing Bruce's Law.

MARCH

Began weekly meetings with Senator Murkowski staff to write Bruce's Law.

Alaska Public Media broadcast Line One with Michael Troster to discuss the Opioid Crisis in Alaska.

Front Page Sunday edition of the Anchorage Daily News with Michael Troster to discuss the Opioid Crisis in Alaska.

Meeting with Anchorage Mayor Bronson and Michael Troster to discuss the Opioid Crisis in Alaska.

MAY

Spoke during the Governor's Press Conference concerning the Opioid Crisis in Alaska.

Called the Anchorage Chief of Police to discuss why APD officers do not carry Naloxone kits.

Started weekly meeting with Governor Dunleavy staff to address the Opioid Crisis in Alaska.

Started getting Naloxone kits from Michael Troster and started handing them out to APD officers myself.

JUNE

Attended US Senate Floor Speech with Michael Troster and Alaska Governor Staff Kim Koval as US Senator Murkowski introduced Bruce's Law. Co sponsored by US Senator Feinstein.

Met with US Senator Sullivan, Governor Staff, Kim Koval and Michael Troster to discuss US Postal Inspectors for Alaskan Taskforce.

Attended 2 day DEA Family Summit on the Opioid Crisis in the United States. Spoke with Administrator Milgram about Bruce's Law.

Press release from Anchorage Mayor Bronson to announce the Mayor's Anchorage Opioid Task Force. Bruce's Law was the impetus.

State wide Public Service Announcements began airing. Content is me speaking about Bruce and the Opioid Crisis in Alaska. Specifically addressing Fentanyl.

JULY

Meeting with Michael Troster and the Director of Alaska DEA, David Zahn.

Meeting with DEA Director, David Zahn and DEA agent Shane Pitts to discuss projects moving forward.

Became a Certified Naloxone distributor through State of Alaska Project Hope.

Attended The State of Alaska Community Cafe to discuss Naloxone distribution and the Fentanyl Crisis in Alaska with community stakeholders and state agencies.

APD continues to refuse to allow officers to carry Naloxone kits.

AUGUST

Organized protest in front of APD headquarters to ask " Why Don't APD Officers Carry Naloxone?"

KTUU news media covered the protest on the evening and morning news broadcasts.

Protest on the front page of the Anchorage Daily News.

2 days after the protest APD Chief interviewed for the Anchorage Daily News and KTUU news media. The Anchorage Police Department will change its policy and allow officers to carry naloxone kits.

Became the Alaska Administrator for Facing Fentanyl

National Fox News interview with Michael Troster, and Derek Maltz, retired DEA and national Fentanyl awareness advocate.

DEA and Facing Fentanyl recognize August 21 as National Fentanyl Prevention and Awareness Day.

Secured a Governors Proclamation declaring August 21 as National Fentanyl Prevention and Awareness Day.

Senator Murkowski recognized August 21 as National Fentanyl Prevention and Awareness Day.

KTUU News Media interview concerning the emergence of Rainbow Fentanyl interdicted in Alaska.

Secured a Governors Warning to the Public on the emergence of Rainbow Fentanyl and urge all Alaskans to carry Naloxone kits.

Alaska Public Media 1 hour radio show, Talk of Alaska, with Michael Troster and Assistant US Attorney Kluggman. Discussed Governors Warning, Naloxone, Prosecutions, Bruce's Law.

University of Alaska Webinar with Dr. Anne Zink, Chief Medical Officer for Alaska. Discussed Fentanyl Poisonings, harm reduction including state wide Naloxone distribution and training.

Prevention and Awareness booth during International Overdose Awareness Day event. Including DEA literature and Naloxone kits.

SEPTEMBER

Front page of the Frontiersman Newspaper covering the International Overdose Day event.

3 day prevention and awareness event, Connection 2022. DEA literature, Naloxone kit trainings and connecting with families of Fentanyl Poisonings.

Distributed Naloxone kits to a music festival with training information and DEA literature.

Article in the Anchorage Daily News for the Connections 2022 event.

Coordinated a Naloxone kit building event with the Anchorage Health Department. Governors staff, Anchorage Mayor and several family members of lost loved ones participated. 1500 kits assembled.

KTUU news interview to cover the kit building event.

Taped a 2 part Dr. Phil show in Los Angeles. Derek Maltz and 8 other parents of Fentanyl Poisoned children participated.

US House Representative Trone, Democrat from Maryland, will sponsor Bruce's Law and introduce onto the floor of the house.

US Senator Murkowski attached Bruce's Law to the National Defense Act Authorization Bill.

US Senator Sullivan secured, with Chief Postal Inspector Barksdale, additional Task Force Officers for Alaska. Additional officers will be fully credentialed by the US Postal Inspection Service to interdict and inspect packages suspected of containing illicit Fentanyl.

First episode of Dr. Phil aired. Several parents of Fentanyl Poisoned loved ones watched at my house.

KTUU News Media reporter was with us and covered the story for Alaska evening and morning news broadcasts.

OCTOBER

Attended Press Conference with Alaska Law Enforcement to announce interdictions and future initiatives related to illicit drugs in Alaska. Enough Fentanyl was interdicted between May and September to kill every Alaskan 3 times.

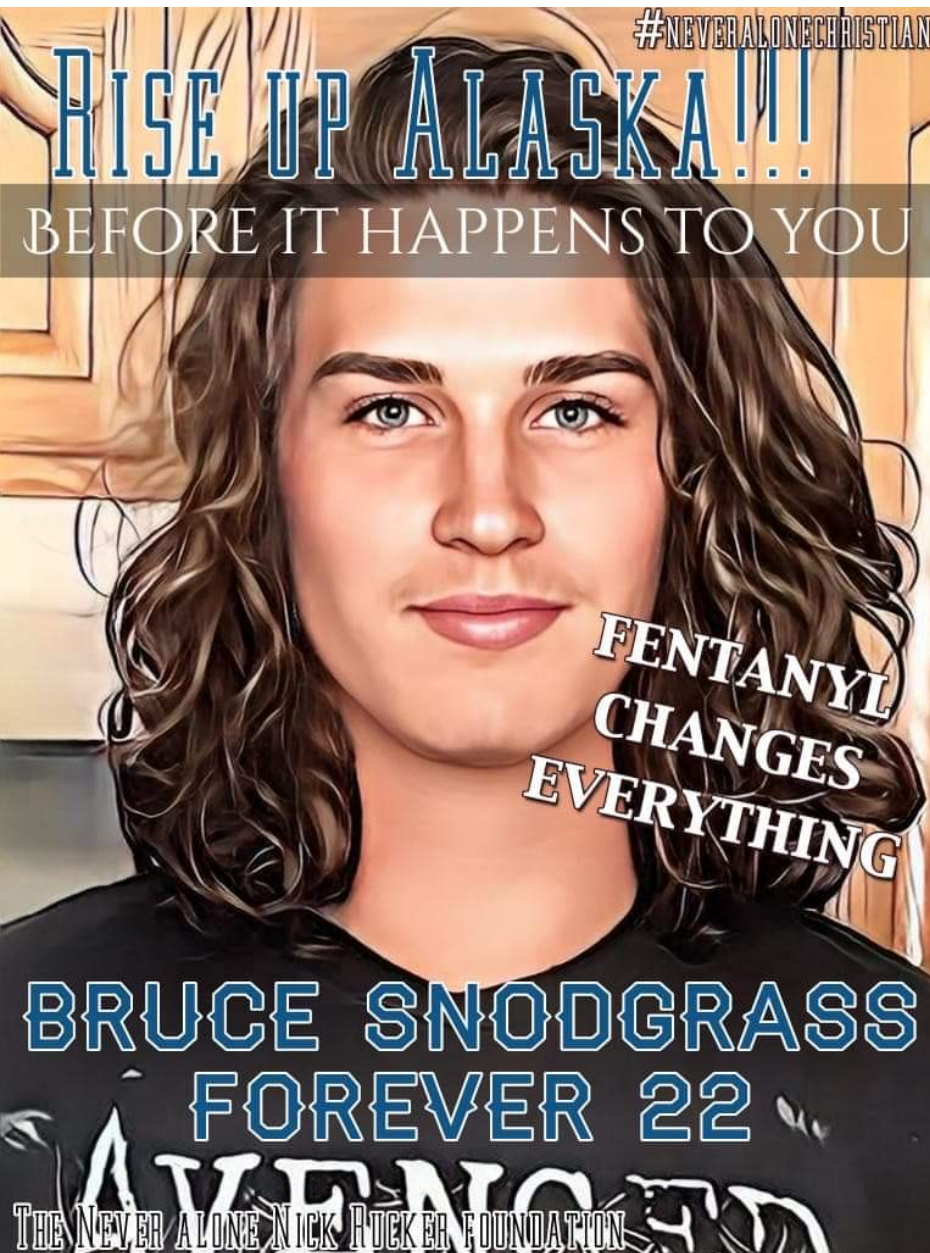
Invited by the DEA to be Keynote speaker to kick off Red Ribbon Week. Event will be held in the Anchorage Convention Center.

Meeting with Anchorage Mayor, Municipal Health Officials and Michael Troster to review applications and begin filling seats for the Anchorage Opioid Task Force.

Meeting with Dr. Anne Zink, Alaska Chief Medical Officer and Michael Troster to stand up an emergency response team to respond to mass poisoning events in Alaskan communities when a "Bad Batch" of illicit drugs has been detected. Response Team will travel with Naloxone kits and wall mounted dispensers to the effected community to provide immediate and life saving interventions.

October 17, 2022 I will attend a press conference where Governor Dunleavy will announce a Governors Bill to: 1. Create a state prosecution statute to charge 2nd degree murder for Fentanyl Poisoning when a death is involved. 2. Remove "good time" from sentencing guidelines when Fentanyl is involved. 3. Direct all monies recovered during drug investigations to the Department of Public Safety. 4. Require Department of Education to provide drug education to all staff and students in Alaska Public Schools. Including providing Naloxone training and kits.

Future endeavors include but are not limited to:

1. Designate Fentanyl as a weapon of Mass Destruction
2. Designate Mexican Drug Cartels as Terrorist Organizations to allow enhanced law enforcement, including Home Land Security.
3. Upon the passage of Bruce's Law the Anchorage Opioid Task Force will become a CADCA Coalition thereby becoming eligible to apply for SAMSHA grants provided by Bruce's Law.

I am hopeful that you see the value of my scope of work to date and will agree to provide funding to enable me to continue and increase my effectiveness to impact the Opioid Crisis in the United States.
